The Radcliffe Department of Medicine provides graduate students with exceptional teaching, training and career development in a broad spectrum of sciences related to medicine. There are more than 100 graduate students currently in RDM, most of whom are studying for one of the two Doctor of Philosophy (DPhil) degrees:

- DPhil in Medical Sciences;
- DPhil in Cardiovascular Medicine.

RDM also plays host to students enrolled on DPhils administered elsewhere, such as BHF/Wellcome Trust funded Doctoral Training Centre programmes or the NIH-Oxford programme, which is administered by the Nuffield Department of Medicine. The Department is committed to training

There is a wide range of training opportunities available across RDM, the Medical Sciences Division and the University. Training events in one Division are often available to students from other Divisions. Of particular note is the comprehensive [Methods & Techniques](#) course run by the WIMM. Attendance at a proportion of the seminars for this course is compulsory for students based in the WIMM, with individual sessions open to all RDM students.

### Advice, Information & Support

The primary source of information for students is their supervisor. The supervisor is best placed to offer advice on all scientific matters and will have considerable knowledge of the workings of the Division in which they are based, the Department and the University as a whole.

Where the supervisor is unable to provide advice, information or support on a particular topic, the DGSs, GAs and administrative staff within the Department are all important sources of information.

In addition to the support on offer within the Department, all students are assigned an Advisor by their college.

The [Student Counselling Service](#) acts in strict confidence and is experienced in helping students with a wide variety of physical and psychological disabilities relating to academic work. Other useful sources of support are listed on the [Health & Welfare](#) pages of the University website.

### Complaints

If a student has a complaint they should initially raise the matter with their local GA. If this is not possible (e.g. if the complaint concerns the GA in question) then it should be raised with the DGS, or failing that the Head of Department. The Graduate Studies Administrator will

also be able to provide assistance with complaints.
